CREDIT APPLICATION TERMS AND CONDITIONS

Credit Application, hereinafter "Agreement", between the Seller whose name and address appear on the reverse side of this agreement, hereinafter "Seller" and Customer-Applicant whose name and address appear on the reverse side of this agreement, hereinafter called "customer", entered into on the date said on the Application is accepted by seller.

WHEREAS, Customer, desires from time to time to make purchases of goods, and/or services

WHEREAS, in lieu of the written purchase order method of establishing the terms of sale, the parties desire to specify terms and conditions. Which shall apply to present and future sales of goods, by seller to customer, whether the order for such merchandise is placed with seller by oral, written, telephone or electronic communication.

NOW THEREFORE, in consideration of the foregoing and of the covenants hereinafter contained Seller and Customer hereby agree as follows:

CREDIT APPLICATION TERMS AND CONDITIONS (CONTINUED)

1. **TAXES** The amount of the present or future sales, revenue, excise or other taxes applicable to the goods sold shall be added to the purchase price and shall be paid by the customer, or in lieu thereof, the customer shall provide Seller with a tax exemption certificate acceptable taxing authority.
2. **Standard Terms of Payment** All orders will be billed **C.O.D.**, pending credit approval All first orders shipped **C.O.D.** All invoices must be paid on a "net of 30 days" basis from the date of invoice, otherwise an interest rate of 1.5% per month, which equals 18 % per annum, will be charged on all past due invoices. Century Blinds Inc. reserves the right to deny credit for any reason, or no reason and revert account back to C.O.D.basis. A service charge of \$25.00 will be applied to each returned check.
3. **Cost of Collection and Attorneys Fees** If customer fails to pay any amount when due, including service and finance charges, Customer agrees to pay the full amount of any cost and/or expenses, including reasonable attorneys fees incurred by Seller in the collection of such overdue amounts by litigation or otherwise.
4. **Delay** Seller will not be liable for any delay in the performance of orders or contracts, or in the delivery of shipment of goods or for any damages suffered by the Customer by reason of such delay is directly or indirectly, caused by, or in any manner arises from, fires, floods, fuel, power, materials, or supplies, transportation delays, or any other cause or causes beyond it's control, whether or not similar in nature to any of the foregoing.
5. **Right Of Possession** Seller shall have the right, in addition to all others it may possess, at any time, or credit reasons to deem itself insecure and withhold shipments, in whole or in part, and to recall goods in transit, retake same, and repossess all goods which may be stored by or with Seller for the Customer's account, without the necessity of taking other proceedings, and the Customer consents that all merchandise so recalled, retaken, or possessed shall become the absolute property of Seller, provided that the Customer is given full credit therefore.

The undersigned binds and incurs the liability of the client, but also obliges him/her personally and jointly and severally with the client to pay any balances owed to Century Blinds Inc.
